DONALD K. EMMERSON

Donald Emmerson is director of the Southeast Asia Forum at Shorenstein APARC and a senior fellow at FSI. He also teaches courses on Southeast Asia in International Relations and International Policy Studies.

His publications in 2003-2004 included "Situating Southeast Asian Studies: Realm, Guild, and Home," in Anthony Reid, ed., Southeast Asian Studies for a Globalized Age: Pacific Perspectives (2004); "Indonesia's Approaching Elections: A Year of Living Dangerously?" in the Journal of Democracy (January 2004); and "Reviving Liberalism, Respecting Local Context" in The Responsive Community (Summer 2003). Other writings since 2000 include pieces on democracy, regionalism, security, and Southeast Asia in the Brown Journal of World Affairs, the Van Zorge Report on Indonesia, and YaleGlobal; in edited volumes such as Asia Pacific Economic Cooperation, The Asia Pacific in the New Millennium, and The Many Faces of Asian Security; and in newspapers such as the Los Angeles Times. In 2001, Gramedia (Jakarta) published his expansion and Indonesian translation of a volume he edited, Indonesia Beyond Suharto: Polity, Economy, Society, Transition (Armonk, NY: M.E. Sharpe, 1999).

In 2004, Emmerson took part in two working groups on U.S.-Asian relations--one organized by the Asia Foundation to evaluate "America's Role in Asia" and another sponsored by the Stanley Foundation on the United States and Southeast Asia. Also in 2004 he helped to plan scholarly meetings at Stanford on Southeast Asian studies in relation to political science and on the contrasting approaches of French and American analysts of Islam. In 2003-2004, he held advisory positions with the Fund for Peace, the National Bureau of Asian Research, the Journal of Democracy, among other bodies. In 2003 SEAF cosponsored a National Commission on U.S.-Indonesia Relations whose report was submitted to the U.S. Congress and the executive branch toward the end of that year.

Emmerson lectures frequently on Southeast Asian topics. In 2003-2004 he spoke at Cornell University, Johns Hopkins University, Princeton University, Stanford University, the University of British Columbia, and the University of California, Berkeley. A lecture tour of Australia in 2001 took him to nine campuses in seven cities in that country. He has testified before Congress on Southeast Asian subjects, most recently in 2001 and 1999. In 1999, for the Carter Center, he observed Indonesia's national election in Ambon and the UN-administered vote on autonomy in East Timor. In 2003-2004 he was interviewed by the BBC, the *Jakarta Post*, KPFA (Los Angeles), KTEH TV (San Jose), Metro TV (Jakarta), Public Radio International, Radio Singapore International, the *Straits Times* (Singapore), the Voice of America, the *Wall Street Journal*, and *Yomiuri Shimbun* (Tokyo), among other media.

Prior to moving to Stanford in 1999, Emmerson was a professor of political science and Southeast Asian studies at the University of Wisconsin, Madison. His Yale dissertation, *Indonesia's Elite: Political Culture and Cultural Politics*, was published in 1976. He and his wife, Carolyn, have two daughters. As an undergraduate at Princeton, he majored in international affairs at the Woodrow Wilson School.
