

Vision 20: International Summit on Global Governance's New Frontiers

IAR Organizes Coalition of Global Think Tanks Ahead of China's G20



Faculty members, senior administrators, and graduate students from the Institute of Asian Research were in Hangzhou, China at an event coordinated by Professor Yves Tiberghien, Director of the Institute. The event, which brought together a large global coalition of policy schools and think tanks, sought to bring COP 21 and Sustainable Development Goals (SDGs) into the leadership priorities of the forthcoming G20 summit.

The event brought together fifty world-class speakers and a dozen universities to seek a bigger-picture approach to the G20, initiate a new network, and produce a blue paper and book to influence the G20 in September 2016.

Members of the University of British Columbia were present at every panel.

Student Leadership and Experience

After an open selection process, a team of 22 UBC students, along with staff and volunteers, was put together in January.

The 22 UBC students included five MAAPPS students, one MPPGA student, nine political science graduate students and postdoctoral fellows, and two Sauder students.

The student team created the term Vision 20 (V20), its logo and the communications plan. The students also managed key VIPs on the ground.

A highlight of the summit was a working group on Saturday, April 2 to discuss the results and the blue paper. Two tables were set up: one with ten top global scholars and the other with UBC students. The two groups proceeded to partake in lively interactions and debates (photo below). This was an unprecedented experiment.

Students also embarked on tours of Hangzhou and engaged in a roundtable discussion with Peking University professors in Beijing on Sunday, April 3.

A blue paper core committee was put together to work on three outcomes:

- 2. A Blue Paper (30-page report) to be disseminated globally, including at Think 20 and to governments
- 3. Blue book to be published this summer by Zhejiang University
