



## Master of Public Policy and Global Affairs Overview of Pre-requisite Courses

[The Master of Public Policy and Global Affairs \(MPPGA\)](#) is a 20-month professional program offered at the University of British Columbia (UBC) in Vancouver, B.C. The first year of the program requires students to follow mandatory core courses across a wide range of disciplines, including communications, economics, quantitative methods, and public management.

The MPPGA Program Office requires applicants demonstrate knowledge of microeconomics, macroeconomics, and statistics/quantitative methods **at the introductory level** at a post-secondary institution. At minimum, we would like applicants to have the level of economics or statistics/quantitative methods knowledge normally acquired from a 100-level (1st year) introductory course. This is to prepare for the following courses:

- PPGA 500 – Economics for Policy
- PPGA 503 – Measurement and Data Analysis for Policy

In order to be best prepared for the program, students should have completed one option from the below in the last five years. Students must complete these courses no later than July 31<sup>st</sup> of the year in which they are starting the program.
